

## MyWhoosh Cycling Esports Sanctions

In the interests of transparency, the following is a list of athletes currently serving sanctions for violations of the MyWhoosh Cycling Esports Rules & Regulations following the completed investigations. MyWhoosh will update this list upon determination of such sanctions except in cases in which MyWhoosh deems publication would be inappropriate.

Once a sanction is published to this list, MyWhoosh considers the matter closed. As a reminder, although increased public scrutiny of listed rider performances and behavior is to be expected, MyWhoosh does not and will not tolerate any conduct intended to harass, threaten, or intimidate other users. Such conduct violates the MyWhoosh Terms of Service and any such cases will be investigated.
